Constitution of Task Force Committee under the Chairpersonship of Chief Secretary to Government for Simplification of Service Delivery Mechanism under Ease of Doing Business Initiatives in Karnataka.

### PREAMBLE:

DPIIT, GoI vide email dated 31.01.2024 released Business Reforms Action Plan (BRAP) 2024 for implementation by Central Ministries and States/UTs. The framework is structured into two parts: Part A, includes 57 reforms from 11 Central Ministries/Departments, and Part B, includes 287 reforms aimed at implementation by states and UTs. In continuation, DPIIT, GoI vide email dated 24.10.2024 introduced BRAP Plus (BRAP+) with 70 new reforms. Consequently, the BRAP 2024 assessment cycle now encompasses a total of 344 reforms, which includes the original 287 reforms, the 14 deletions, and the 70 additions.

Minimising Regulatory Compliance Burden Plus (RCB+) is also introduced as a part of revised framework to provide impetus to Ease of Doing Business through Process Simplification, Elimination of redundancy, Digitisation and Decriminalisation.

Government of Karnataka is progressively working towards Minimising Regulatory Compliance Burden for Businesses with special focus on Business Process Re-engineering. In this regard, EODB Coordination Committee has been formed vide Government Order No. CI 264 SPI 023, Bengaluru dated 31.10.2023.

As a part of regulatory and technological shift due to initiatives taken under Ease of Doing Business, majority business-centric processes and procedures have been streamlined and digitized and hence, further transitioning to self-certifications/third-party certifications may enhance compliance efficiency.

In addition, as a part of EODB-State Business Reform Action Plan+ 2024 (Reform No. 356), States/UTs shall ensure the creation of a task force to identify sectors and their respective necessary approvals/compliances (applicable across sectors) suitable for transitioning to:

• Self-certification for low-risk inspections and

• Third-party certification for medium-risk inspections

The proposed mechanism may also incorporate stakeholder consultations for reinforcing industry confidence and ensuring the reforms meet business needs. The effective implementation of task force recommendations will be key for establishing an efficient, transparent, and supportive business environment.

To promote Ease of Doing Business and Ease of Living in Karnataka, a Task Force required to be constituted, which shall be responsible for identifying approvals / compliances suitable for transitioning to:

1. Real time approvals/Deemed approvals/Auto-renewal/ Perpetual Licensing or approval.

2. Self-certification for low-risk inspections.

3. Third-party certification for medium-risk inspections.

4. Process Simplification through streamlining regulatory processes, reduction in form size, number of procedures, cost and time of Certificate(s), License(s) & Permission(s) to make compliance easier for applicants.

5. Elimination of Redundancy (repealing of Acts/Rules/ Regulations) such as requirement of maintaining registers, records or display,

filling producers and others.

6. Decriminalization (reducing the severity of punishments for technical/procedural errors and minor non-compliance).

In view of the above, for Simplification of Service Delivery Mechanism under Ease of Doing Business Initiatives in Karnataka, Commissioner for Industrial Development & Director of Industries & Commerce proposed to constitute a Task Force Committee under the Chairpersonship of Chief Secretary to Government and Development Commissioner & Additional Chief Secretary to Government as Co-Chairperson and Commissioner for Industrial Development & Director of Industries and Commerce as Convenor along with the heads of the concerned line Departments as members;

The Task Force shall be empowered to co-opt any additional members or experts as deemed necessary for attainment of its objectives.

#### **Terms and Conditions:**

- 1. To streamline the necessary approvals and compliances that may be simplified as per aforementioned indicated categories.
- 2. To obtain inputs from key stakeholders/subject matter experts through consultations and understand business/applicant's need.
- 3. To develop a framework for self-certification for low-risk sectors, ensuring minimal regulatory burden while maintaining compliance integrity.
- 4. To establish guidelines for third-party certification for medium-risk categories, with a focus on credibility and standardization of the certification process.
- 5. To recommend a mechanism for periodic review and update of the self-certification and third-party certification processes.

6. To submit a comprehensive report with recommendations within 90 working days from the date of this order.
