Sub: Deregulation of Business Environment in Karnataka-
Strengthening of Karnataka Udyog Mitra (KUM) - reg.

Preamble:

Vide Order dated 22.5.1992 read at (2) above, Government had approved establishment of an escort service cell under the name and style of Karnataka Udyog Mitra (KUM) to be registered as a Society, under the Societies Registration Act and authorized Commissioner for ID & Director of I & C to take all actions necessary for registration of the Society after formulation of suitable articles, Memorandum of Association, Bye Laws etc, with the objective as set forth in the preamble portion of the said Government Order dtd:22.5.1992.

The Commissioner for ID & Director I & C, in his D.O.letter dated 26th June 2001 read at (1) above, has sent proposals for strengthening KUM as a part of "Deregulation of Business Environment" approved by the Government. The proposed Deregulation measures interalia, envisage providing a truly Single Window support for various approvals / infrastructure facilitation for implementation of the investment proposals by entrepreneurs. This requires strengthening of the Karnataka Udyog Mitra (KUM), which is being designated as a "Nodal Agency" for providing comprehensive support services / approvals for investors / entrepreneurs. With a view to provide integrated Single Window services for project proponents, it is proposed to have a 'Promotion Wing' which would identify target and bring in investment proposals into the State. This promotional Wing would also undertake the general house-keeping tasks of the organization. It would also bring up projects before the SLSWA / HLC, as the case may be, depending upon the scale of investment, for consideration of approval.

After project approval by the SLSWA / HLC, the 'Facilitation Wing' would take over in securing necessary clearances / approvals required for the project under various statutory regulations / guidelines. In order to effectively deliver these services to the entrepreneurs, it is proposed to draft four officers on deputation from the (i) Inspectorate of Factories & Boilers (ii) Labour Department (iii) KSPCB & (iv) Commercial Tax Department.

Hence the following order.

ORDER NO.CI 196 SPI 2001, BANGALORE DATED 2ND MARCH 2002

After careful consideration of the proposals received and as stated in the Preamble Portion of the said order, the Government approves the modified proposal of Organisation structure of Karnataka Udyog Mitra as per Annexure - I. The Officers drawn on deputation to Karnataka Udyog Mitra will continue to be borne on the rolls of the parent Departments / Organisations and would be eligible to receive their salaries, allowances and other benefits from their parent Department / Organisation.


